**SERVICE OF FUNERAL HOME AND STAFF**

**Professional Services:**

**A. Service of the funeral director and staff ..... \$1295.00**

This list does not include prices for certain items that you may ask us to buy for you, such as cemetery or crematory services, flowers, and newspaper notices. The prices for those items will be shown on your bill or the statement that describes the funeral goods and services you selected. This is a basic fee that we charge every family for our professional expertise in assisting them with their preferences. It includes a proportionate share of the taxes, licenses, utilities and business expenses required to serve the public. Our charge includes, but is not limited to, consultation with the family, administration and clerical services, preparation of the death certificate for agencies, consultation with clergy, cemetery, crematory or common carrier, assistance with union or insurance papers, planning the funeral or memorial services and placement of obituary notices.

This fee for our services will be added to the total cost of the funeral arrangements you select (This fee is already included in our charges for direct cremations, immediate burials, and forwarding or receiving remains.).

**B. Embalming..... \$495.00**

Except in certain cases, law does not require embalming. Embalming may be necessary, however, if you select certain funeral arrangements, such as a funeral with a viewing. If you do not want embalming, you have the right to choose an arrangement that does not require you to pay for it, such as direct cremation or immediate burial.

*Please note: Our mortuary policy requires embalming for any arrangements that include public viewing.*
